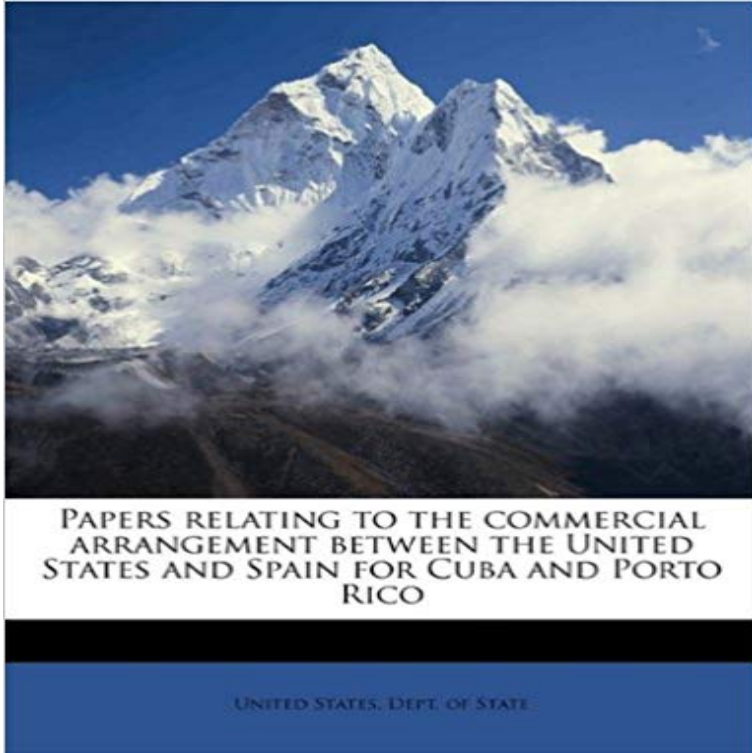


## Papers relating to the commercial arrangement between the United States and Spain for Cuba and Porto Rico
