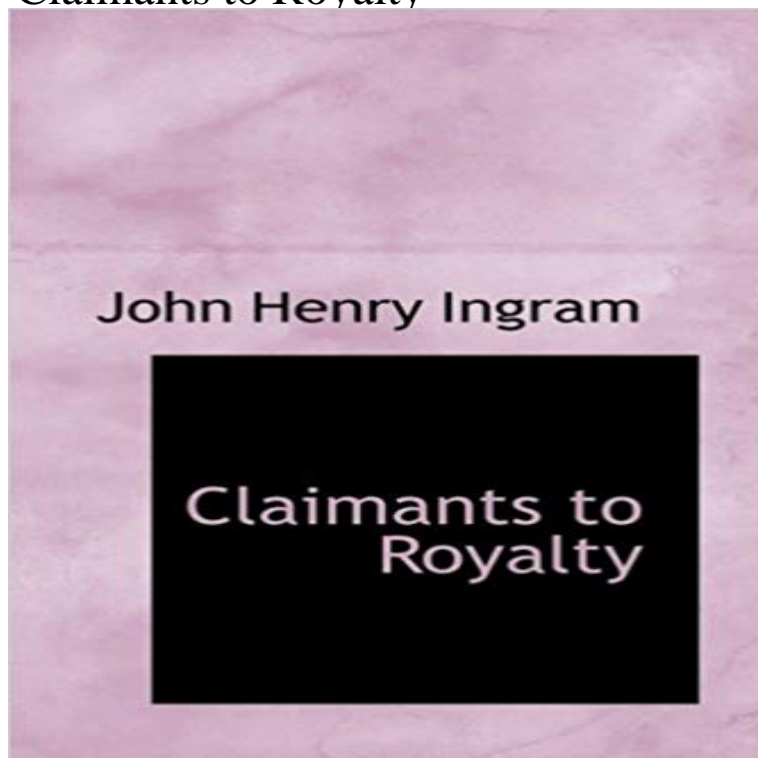


## Claimants to Royalty
